Call to Order: Chair Melissa Marshall called the regular monthly meeting of the Board of Trustees to order at 6:10 p.m. Rafi Ellis recorded the minutes

Board Members Present

Quorum: A quorum was present.

Agenda: The agenda was approved by consensus.

Approval of Minutes: The Board approved the April 2016 and May 2016 Board Meeting Minutes by consensus.

REPORTS

Minister's Report: Rev. Lynne Garner presented the minister's report. She has submitted another letter to the Editor of The Ledger and is expanding her contacts with other local clergy.

Treasurer's Report: Joyce Bode presented the Treasurer's Report.

Committee Reports:

Social Justice Committee report was given by Ron Nickolas. He noted that we provided counseling space in the wake of the Orlando shooting. Ron attended a represent.us meeting; the group works to get big money out of politics. They are discussing possible building use and/or events.

Personnel Committee report was given by Ron Nickolas. John Zych accepted the Music Coordinator position for the next year. Joyce listed the forms he will need to fill out to complete the hiring process.

Worship Committee report was given by Ron Nickolas. All summer services have been scheduled, with members and guest speakers to fill in during Lynne's summer hiatus.

Committee on Ministry report was given by Ron Nickolas. The group has interviewed each member and will compile a report about its findings and their effect on Long Range Planning.

Membership Committee report was given by Rafi Ellis. Two members will be asked to serve as Sexton.

Lifespan Committee report was given by Deirdre Daniel. Alma Sonkoly has organized the library. Chalice Circles continue.

Stewardship Committee report was given by Glenda Littlehale. LRPG will pay \$45/use for facilities usage with a

plan to increase to \$70 per use over the next two years.

Religious Exploration Committee report was given by Heather Curry. Heather has stepped down as DRE. RE is off for the summer. Ron Nickolas moved that we acknowledge Heather's stellar service as our DRE. Glenda Littlehale seconded. The motion was approved without objection.

OLD BUSINESS

Minister's Evaluation: Rev. Lynne expressed concerns about the evaluation process for the UUA Ministerial Fellowship Committee review and some of the comments noted on this year's evaluation. The Board agreed that the process needs refining. The Board also thanked Rev. Lynne for her positive impact on the Congregation, and committed to working with the Committee on Ministry to create appropriate processes for ministerial evaluation.

NEW BUSINESS

DRE Position Changes: Rafi Ellis moved that we accept Deirdre Daniel as the new DRE. Ron Nickolas seconded. The motion was accepted without objection. A new board member will have to be appointed to fill Deirdre's voting trustee position.

Board Summer Availability: The Board will meet over the summer to work on revising the policy manual.

UUCL Security: Once again, the building was left unsecured after usage. The administrator will be asked to compile a list of keyholders, and each keyholder will receive training in how to properly secure the building after use.

General Assembly: As GA Delegate, Deirdre Daniel noted that this year's GA theme, "Heartland: Where Faiths Connect," relates to recent programming requests, including restarting CUUPs, partnering with an African-American congregation, and working more closely with our facilities users, Hokori Zen Center. She wants the Board to consider ways of partnering with other faith groups.

Calendar: The new fiscal year begins on July 1. Melissa Marshall will schedule a Board retreat for an upcoming Saturday. The book discussion will be moved to Aug. 21. The next Board meeting will be held on July 18, 2016.

Minister's Report June 13, 2016

We have made it through the year, and I think in general, things have gone well. I won't go into details here since I did that in my report to the congregation, as well as this past Sunday's sermon. I will simply concentrate on this month's details, as usual, and the summer months, since I will not be reporting to you again until then.

I continue to make new connections in the community with people who have never heard of Unitarian Universalism or our congregation. Hopefully we can think about how better to reach more of these people. Certainly the much improved website should help.

We have had some more hospitalized members this past month, unfortunately. I made visits to hospitals in Lakeland and Tampa. Those members seem to be recovering slowly and will need congregational love and support this summer.

With the tragic shootings in Orlando, I contacted the minister in Orlando to offer any assistance she or her congregation might need. She has replied that they have things covered. At Ron Nickolas' suggestion, we are offering our sanctuary to therapist Heather Stambaugh (sp?) and other professional colleagues tomorrow night (Tuesday) for grief counseling. I have offered to open the door for them. I believe that this is a good use of our space in a time of crisis. Tonight, weather permitting, I intend to join some of our members at a candlelight vigil at Lake Mirror in memory of the victims and in solidarity with our LGBT neighbors.

I have had more lunches and visited more people in their homes and will continue to do so this week.

Next week will be a working week away as I will be attending Ministry Days and then General Assembly in Columbus. Jerry will be attending as well.

I continue to attend NAACP general and executive committee meetings. In mid-July, during my vacation, I will spend five days in Cincinnati at the National Convention of the NAACP as one of the delegates from our local branch. I look forward to that as an opportunity both to learn and to make connections with new people.

Next year, I would like to have regular (i.e. monthly) meetings with both the board chair (and perhaps the vice chair) and the director of religious exploration. I felt the lack of contact this year, but was reluctant to push meetings because I sensed there was a lot on everyone's plate, both personally and professionally. I believe that better and more frequent connections would serve the congregation so that we can work together more smoothly and be on the same page.

After next week, I will be on vacation through July 15 and then on study leave. I will be back in Lakeland for a few days following GA but then will be spending most of the summer either in Chicago or New York (with my father). Per the contract, if you should need me to come back to Lakeland for an emergency situation, the travel will be at the congregation's expense during my vacation but at my expense during the study month. Oh, and I need to sign a new contract.
